Parents/Guardians:

Attached you will find the Tuition Schedule that was effective September 1, 2020. Beginning that date, only M-F, MWF, or T/TH will be offered for guaranteed slots. If you need a day other than MWF or T/TH, you will need to either reserve M-F or request to do drop-in and pay the daily rate for those days, which is based on availability and not guaranteed. Diapers and wipes will no longer be offered except to supplement when a parent forgets to bring them.

Please review the new handbook regarding the changes with monthly tuition, semester fees, discounts, etc.

I would like to share some facts about the Children's Learning Center that set us apart from other centers in the region. *We are one of two centers in the county that is Texas Rising Star and we have had this accreditation since 2008 - https://texasrisingstar.org/. We are the only center in the county that has a national accreditation (NAC) - www.earlylearningleaders.org/?page=accreditation. This means that we follow the highest possible standards when caring for your child.

- *We participate in the Federal Food Program. This allows us to provide free meals to our children at no cost to you. This program ensures we are serving allowable foods, using federal money wisely, and meeting health and sanitation requirements.
- *The majority of our staff have a CDA or college education even though Texas only requires a high school diploma. NAC requires staff to have at least 30-35 hours per year of training specific to childcare to include FA/CPR.
- *We use NAC ratios, which means less children per staff member, and often times have more staff than required due to the setup of the building. Age groups are also not mixed unless absolutely necessary.
- *We cater to students by offering part-time care. This is not the norm in the area, nor in the university realm. In fact, the norm is to require all families to pay for a full time slot.
- *We have the CCAMPIS grant that helps pay up to 75% of childcare tuition for student families.

I am truly grateful for you allowing us to care for your child (ren). Putting out information like this can be extremely difficult in any business, but especially when we have the relationship, we do with you and your child (ren). Thank you for understanding, and if you would like more information about how we came to these decisions or about anything mentioned in this letter, please let me know.
